

ERYICAdeMy - Training of Trainers in Youth Information and Counselling

2022 - 2023

Draft training programme

The ToT course consists of two residential courses of 3 and 4 working days and two eLearning phases of 5 and 6 weeks, spread over a period of 6 months.

Please note that the current program and training dates are tentative and subject to change.

Preparation phase and motivational interviews: 10-23 October 2022 (2 weeks)

- Expectations, motivation, participation
- The ERYICA competency circle
- Motivational interview
- Self-presentation

1st eLearning phase – 24 October – 27 November 2022 (5 weeks)

Expected workload: approx. 3 hours/week

Content:

- 3 webinars and online activities
- Introduction to the course, its purpose and structure
- Getting to know participants and trainers
- Background on youth information
- The YouthInfoComp framework and other core documents
- The ERYICA training system 1
- Skills development
- Analysis of the national situation
- Creation of a development plan with the nominating organisation

1st residential course – 5-10 December 2022 (tentative dates: 4 training days + 2 travel days, planned to take place in Portugal)

Content:

- Getting to know each other (in person); community building
- Purpose of the ToT: reminding of aims, objectives, activities, methods, expected results
- Introduction and explanation of youth information training realities
- Role of the trainer: Professional and trainer identity
- The ERYICA training system 2
- Pedagogy and andragogy
- Working through the courses in the YIntro family – understanding the needs for courses, their content and expected learning outcomes, getting familiar with the concepts and methods of the courses
- Familiarising with the back end of Moodle – get familiar with Moodle platform, understand how it works and possible ways of use, how to create and manage an

online course, to understand better the differences and possibilities of F2F and online courses

- Reflections on 1st eLearning phase
- Instructions and planning for the 2nd eLearning phase
- Mid-term evaluation and feedback

2nd eLearning phase – 16 January – 26 February 2023 (tentative dates; 6 weeks)

Expected workload: approx. 3 hours/week

Content:

- 3 webinars and online activities
- Introduction to the Module – explanation of aims and objectives, way of working and the module itself (topics, assignments, etc.)
- Reflection on assignments after the 1st residential module (development plans) and the development of the course
- eLearning Kit and Quality tool (presentation, explanation, individual work - reading)
- Course work with the 8 courses listed above
- Reflective practice from the 2nd eLearning phase: lessons learnt, experience, feedback
- Tune-in for the 2nd residential – preparation of micro-teaching

2nd residential – 13-17 March 2023 (tentative dates; 3 training days + 2 travel days, planned to take place in Spain)

Content:

- Introduction to the module and explanation of expected results
- Recap on 2nd e-learning phase and the development plans
- Micro teaching activities (face-to-face training delivery) and method development – practical learning with training and group comments and feedback
- ERYICA training guidelines
- Training course organisation, management and delivery
- Plan for delivering courses and the related procedures
- Covision and method development
- Conclusions
